

Contest Rules

ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

1. Eligibility

Employees of Channel of Blessings, Inc. and other companies associated with the promotion of the Stories Lived Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

2. Sponsor

3. Agreement to Official Rules

Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. 4. Contest Period

The Contest begins on April 26, 2017 at 12:00 pm EST and ends on September July 26, 2017 at 11:59 pm EST (the "Contest Period"). The Sponsor reserves the right to extend this deadline. Entries that are submitted after the Contest Period will not be eligible for the prizes under the current contest period, but entrants will be invited to have their submissions included in the next contest. Submissions will be accepted for the duration of the Contest using any of the following methods: Online at www.StoriesLived.com.

5. How to Enter

Online: This method of entry will be available by visiting our website (www.StoriesLived.com) and following the directions provided to fill out the entry information, and submit.

There are no limits on the number of entries per individual.

6. Awarding of Prizes

Awarding of Prizes is as follows:

- 9 Finalists – \$200 awarded to each finalist. The top three videos from the three categories (Personal Mission, Personal Passion, and Personal Triumph) will be finalists.
- Audience Inspired Award – \$1,500 awarded to winner from aforementioned 9 finalists across the three categories. Stories Lived will determine the ultimate winner through an online vote. Announcement made on or about August 4th, 2017.
- Jury Inspired Award - \$2,000 awarded to winner from aforementioned 9 finalists. Winner selected by Stories Lived Jury. Announcement made on or about August 4th, 2017.

The Sponsor will attempt to notify the potential winners via telephone or email per the dates noted above. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select alternate potential winners in his/her place based on the next highest vote receiving eligible entries.

All winners will be notified directly, and the winners will be announced on the Stories Lived website, and via Stories Lived social media.

7. Winner Notification

The potential winners will be notified by email or phone. Each potential winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize. If the potential winner is at least 18 years old but still considered a minor in his/her jurisdiction of residence, Sponsor reserves the right to award the prize in the name of his/her parent or legal guardian, who will be required to sign the Declaration of Compliance on the potential winners behalf and fulfill any other requirements imposed on winner set forth herein. 9. General Conditions

for any other reason, as determined by Sponsor in its sole discretion, the Sponsor may, in its sole discretion, either (a) suspend the Contest to address the impairment and then resume the Contest in a manner that best conforms to the spirit of these Official Rules or (b) extend the Contest. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner or for attempting to submit an entry with inappropriate content. Sponsor reserves the right to determine what is inappropriate content. Any attempt by any person to damage the website or undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision. The Sponsor reserves the right to use any entries for advertising or other promotional purposes. All entries must include (1) begin with the Stories Lived bumper intro (downloadable at the website) and (b) conclude with the stories lived ending bumper, "Vote for my video at www.StoriesLived.com."

10. Release and Limitations of Liability

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrants rights and obligations, or the rights and obligations of the Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of Florida, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than Florida.
